A sister she never knew, and a father he hardly remembers... Two help-seekers come to Crime Library Singapore with cold cases of the brutal murders of their loved-ones decades ago. The victims’ families tell their story, as volunteers from CLS try to reignite the trails and retrace the steps of the cases that the public have all forgotten. Will they make progress and will the help-seekers be able to find the closure they need?
